### **Retail Specialty Food Associate**

This position working in all of the departments in the downstairs part of the store requires the candidate to perform the following essential duties

1. Customer Service: answering questions; running a computerized cash register; assembling customer orders; interacting with the public and co-workers in a pleasant manner.
2. Cleaning & Maintenance: maintain a clean and sanitary workspace and breaking down and cleaning the entire area; cleaning and organizing storage areas; communicating inventory needs to Manager when appropriate.
3. Food handling & Preparation: handling foods to maintain food safety and sanitation standards; slicing and packaging deli meats, cheeses and bulk items; weighing and brewing coffee.
4. Lift and carry up to 35 lb. boxes and bags of supplies.
5. Regular and consistent attendance is required.

Starting pay is \$12.00 per hour or more depending on experience and ability. Benefits include paid personal days, holidays, vacation time, health insurance costs reimbursed, retirement plan with employer contribution, and store discounts.
